# CALL TO ORDER / OPEN SESSION

## FISCAL SERVICES

**FS-29** <u>Bid Award – Fence Installation</u> – Mr. Ken Stoppenbrink explained that he would recommend that the Board of Trustees reject the bids received as they were incomplete and excessive. Discussion took place concerning the possibility of separating out the phases of the project.
