FS-38 Memorandum of Understanding – Dr. Frank Gornick explained that the Memorandum of Understanding is for the exchange of property from Lemoore Union Elementary School District to West Hills College Lemoore for the child development center. We deeded the land to them for their

project and they are leasing back a portion to us for 99 years. Trustee Minnite questioned if there are any fees involved. Dr. Gornick stated that there are no additional fees.
