# CHANCELLOR'S OFFICE

CO-62 Resolution (Corrected) – Adopting Final Plan for Adjustment of Trustee Area Boundaries – Trustee Minnite asked for clarification on the corrected resolution. Mr. Sean Welch explained that there was a technical error which relates to the location of the northern boundary between Trustee Areas 5 and 6 which resulted in the unintended placement of two current Trustees in the same Trustee Area. As this was not the intent of the Board of Trustees in approving Resolution CO-62 and is counter to the redistricting guidelines adopted by the Board in Resolution CO-51, a technical correction has been made. It is non-material in nature and preserves and is fully consistent with the original intent of the Board in adopting Resolution CO-62.

The corrected Resolution CO-62 was approved on a motion by Trustee Minnite, seconded by Trustee Cantu, and carried on the following roll call vote:

Brief discussion took place concerning cash flow and Dr. Gornick stated that our last payment will be delayed but our cash flow is fine.
