July 20, 2004



# CALL TO ORDER / OPEN SESSION

President Levinson called the meeting of the Board of Trustees to order at 3:11 p.m.

# CHANCELLOR'S OFFICE

- CO-1 <u>Curriculum Committee Action Report, Spring 2004</u> The Curriculum Committee Action Report for Spring, 2004 was approved on a motion by Trustee Minnite, seconded by Trustee Oxborrow, and carried unanimously.
- CO-2 West Hills College Coalinga Strategic Plan Dr. Gornick commended Dr. Tricoli and his staff for developing the strategic plan for West Hills College Coalinga and stated that they did a great job. Dr. Tricoli distributed an updated version of the strategic plan and reported that it is a beautiful document that wraps up goals, values and vision.

The West Hills College Coalinga Strategic Plan was approved on a motion by Trustee Minnite, seconded by Trustee Ivans, and carried unanimously.

### FISCAL SERVICES

- **FS-1** Fiscal Services Report Mr. Jack Mahrt distributed the budget report and briefly discussed the status of the budget expenses and ending balance. President Levinson questioned when the augmentation is coming. Mr. Mahrt reported that we should have the paperwork soon. The bid has been awarded and augmentation has been requested. It was reported that we will begin moving in about 60 days. Dr. Gornick requested that Ms. Frances Squire, Director of Marketing, let everyone know about this movement.
- **FS-2** <u>Resolutions California Department of Education Contracts</u> The following resolutions certifying the approval of the California Department of Education contracts were adopted on a motion by Trustee Minnite, seconded by Trustee Ivans, and carried unanimously:

- **FS-3** <u>Resolutions Final Project Proposals</u> Dr. Gornick stated that we have good numbers going into Sacramento and the projects look good. We

have informed them to move forward on the North District Center, Firebaugh project. The Chancellor's Office is kept abreast of what we are doing. The Lemoore projects are considered campus build-out projects. Dr. Gornick reported that Chris Addington is hopeful that our numbers will work. Dr. Gornick briefly explained the point system that is used. On a motion by Trustee McKean, seconded by Trustee Henry, and carried unanimously, the following resolutions in the matter of Final Project Proposals for the following projects were adopted:
