

WEST HILLS COMMUNITY COLLEGE DISTRICT

The West Hills Community College District is a public institution of higher education. It offers Associate Degrees that transfer to the four-year university system (AD-T), Associate Degrees (AA/AS), and certificates of completion for career technical education and other disciplines. The district is made up of Coalinga College and Lemoore College, and a center located in the City of Firebaugh. The district office offers contract education courses, along with not-for-credit courses through our Skills Valley Institute and other grant projects. The district serves the communities of Dos Palos, Firebaugh, Mendota, San Joaquin, Tranquility, Five Points, Riverdale, Coalinga, Huron, Avenal, Armona, and Lemoore. The district is 2,932 miles across and serves over 10,500 students every year. We also employ almost 550 staff members throughout the district.

DISTRICT GOVERNANCE

The Board of Trustees of the West Hills Community College District exercises legal authority for its governance and operations pursuant to the California Education Code and Title 5 of the California Code of Regulations. 
The governance publications include:

Board Policies-A formal statement of intent that provides clear direction from the Board in a specific program or operation. The Board of Trustees establishes policies to implement the district's operations and programs. All Board Policies are adopted, amended, superseded, repealed, and suspended at regular board meetings when they are up for review.

Administrative Regulations- Administrative Regulations (AR) are established to provide procedures as outlined in the district policies. Administrative Regulations are developed and implemented at the participatory governance level, meaning that each constituency is included at all levels of review. The Board does not approve the ARs, but they are reviewed and approved by the Chancellor's Cabinet.

Title 5, California Code of Regulations § 51014 authorizes the appointment of one or more non-voting members to the Governing Board. The West Hills Community College District Board of Trustees sets aside one non-voting student trustee on the Board each year.






STUDENT TRUSTEE ROLE

It is the student's responsibility to be informed about the West Hills Community College District and its operations to represent the student voice throughout the district. To become acquainted with the role of student trustee and what other students may expect of you, it is recommended that you:

- 1.Meet with the Chancellor, or representative, as soon as you can so he/she/they can help you understand the role and some of the logistics of the position (i.e., payroll, conflict of interest forms, business cards, etc.)
- 2. Attend orientation with the Chancellor or a representative.
- 3.Read Board Policy 2015- Student Member, Board Policy 2105, election of student member, and Administrative Regulation 2105- Election of Student Member (will be provided to you during orientation).
- 4. Attend meetings and conferences related to the position:
 - a. Board Meetings
 - b. Student Senate Meetings, Club Events, and each campus
 - c.College-wide meetings (as permitted by the chair)
 - d. Monthly meetings with the campus advisor
 - e.Conferences related to the position, as needed and as your schedule permits. These are not mandatory, but if you can attend, it would be a good learning experience.



RESPONSIBILITIES

Student Trustee Role- to represent the student voice on the Board of Trustees. The student trustee, who has an advisory vote, shall be seated with the elected members of the governing Board. The student must be enrolled at one of the colleges throughout the district, be in good academic standing, and meet the district's specified criteria to serve on the Board.


The general responsibilities of the student trustee include:

- 1. Serve as the student liaison between students and the district.
- 2. Attend scheduled Board of Trustees meetings, except closed sessions.
- 3. Participation. During all meetings, the student member has the right to participate in discussions, ask questions, and be seated with the Board. As an official member of the Board, the student member is entitled to receive materials furnished to regular board members, except for materials related to closed sessions.
 - a. Student trustee will receive agendas, reports, and materials at the same time as other trustees (Brown Act, GC § 54954.2).
- 4. Work with advisors on matters pertaining to students.
- 5.Oral Report to the Board of Trustees during meetings. This is not mandatory; however, it is recommended that the student trustee keep the elected board members informed of student activities happening at each campus and center.
 - a. The student trustee should work with the two colleges and the center to obtain information to report during the board meetings.
- 6. Attend regular meetings at each campus and center.
- 7. Plan activities, including legislative activities, with Associated Student Government members at each campus.
- 8. Collaborate with campus ASG advisors, faculty senate, and administrators at all campuses on items related to participatory governance.
- 9. Advocate for students respectfully while acknowledging fiduciary duties.
- 10. Reflect on advocacy efforts, meeting attendance, and student engagement when working on the board self-evaluation.











RIGHTS OF THE STUDENT TRUSTEE

- 1. Access to Information
 - a. Review public records related to board decisions (California Public Records Act, GC § 6250 et seg.).
- 2. Freedom of Expression
 - a. Voice opinions on all matters before the Board, including budget, curriculum, and campus policies.
- 3. Receive mandatory training on:
 - a. Brown Act compliance (CA Ed Code § 72023.5).
 - b. Conflict of interest laws (Political Reform Act, GC § 81000 et seg.).

COMPENSATION

- 1.Student trustees earn a monthly stipend of \$240.00 for attending regularly scheduled and special board meetings.
 - a. There is also mileage reimbursement for travel to and from the board meetings.
 - b. The student trustee will be reimbursed for all approved travel to conferences.

LENGTH OF TERM

June 1st of each year to May 31st

CODE OF CONDUCT

The student trustee will be expected to follow district and college standards of conduct at all times and will use the proper channels of information and represent students' needs to the Board of Trustees and the district's needs to the students.

CONFLICT OF INTEREST


The student trustee shall complete a Conflict-of-Interest Form 700 upon taking office. The form will need to be filled out again in January, marking the start of the new year. The student trustee will recuse themselves from votes or discussions where a conflict exists. (Government Code § 1090)

The students' trustee will adhere to the bylaws of the Board and all district ethics policies.

RECOMMENDED COMMUNICATION

Week 1: Send an introductory email to students introducing yourself and your role as student trustee. Monthly: Publish board meeting summaries on the platform that student leaders and all students have access to.

Quarterly: Participate in student discussions with each individual campus.


