BUILDING CONSTRUCTION CONSISTS OF A BRACED STEEL FRAME STRUCTURAL SYSTEM, CONCRETE SLAB ON GRADE, ELEVATED CONCRETE/METAL DECK SECOND FLOOR, STRUCTURAL METAL ROOF DECK, BUILT-UP MEMBRANE ROOFING AND METAL ROOFING, INTERIOR AND EXTERIOR METAL STUD FRAMING, EXTERIOR FINISH OF CEMENT PLASTER WITH CONTINUOUS INSULATION, AND SHALL INCLUDE AND AUTOMATIC FIRE SPRINKLER SYSTEM.
