(taking over following Steve Reynolds' resignation), and 2) get some clarity on District Recommendation #1 (Improvement) that we received as a result of our March 2017 site visits:

**District Recommendation 1 (Improvement):** In order to increase effectiveness, the team recommends that the district update the evaluation instrument of academic administrators to formally and consistently include the use of results of learning outcomes assessment to improve teaching and learning. (III.A.6)

Given that this recommendation only references Standard III.A.6 (now deleted), what, if anything, will our colleges be required to address for this recommendation in their midterm reports and in general?
