## **Annual Report**

July 1, 2014 – June 30, 2015

## I. Description of School Facilities Improvement District No. 1:

In the November 4, 2008 general election, the West Hills Community College District (WHCCD) succeeded in obtaining authorization from the Coalinga area's voters to issue \$11,800,000 in general obligation bonds. The School Facilities Improvement District No. 1 (SFID-1/ Measure Q) was a facilities and equipment bond measure on the ballot. Proceeds from the sale of the bonds were to be used for financing the long-term construction and facilities improvement projects at North District Center (NDC).

## **II. Citizens' Bond Oversight Committee:**

The Committee does not make decisions regarding the use of SFID-1/ Measure Q funds, but it does inform the public of bond revenue expenditures. To carry out its stated purpose, the following duties are set forth in the Committee Charter:

Inform the public concerning information regarding the WHCCD's expenditures of revenues received from the sale of SFID-1/ Measure Q approved bonds.

Review expenditures to ensure that the bond proceeds are expended only for purposes set forth in the ballot.

Ensure that no bond proceeds are used for teacher or administrative salaries or other operating expenses.

The Committee shall present to the WHCCD Board of Trustees an Annual Report in written format; which shall include a statement indicating whether the WHCCD is in compliance with the requirements of Article XIIIA, Section 1(b) 3 of the California

Constitution; and a summary of the Committee's proceedings and activities of the preceding fiscal year.

The Committee met on June 2, 2015 at the NDC facility in one of the available classrooms.

Project updates are provided at each meeting along with financial reports by WHCCD staff, along with performance presentations from WHCCD consultants on topics of project planning, execution and completion. Agendas are developed from Committee member's request for data and staff input.

The Committee elected to change the meeting dates to have one meeting in the spring (Annual Meeting) and one meeting in the fall until the Center Expansion project is funded, then the committee will then meet more frequently. The meetings for the upcoming year are scheduled to be held on November 8, 2016 and the annual meeting will be on February 2017.

All agendas and minutes are posted on the NDC office bulletin board and also on the Measure Q website (www.Measure -q.org). Meetings are held in accordance with the Ralph M. Brown Act (Open Meeting Laws).

### IV. Activities of the Committee:

The following are activities that the Committee regularly participates in:

Approval of minutes from prior Committee meetings

The Committee reviews budget, construction project analysis reports and reconciliation for SFID-1/ Measure Q revenues and expenditures as presented by Richard Treece, Planner with AP Architects and President Carole Goldsmith, WHCC.

The Capital Outlay Projects and Revenue Bond Construction Funds (Measure C, E, Q, and T) Financial and Performance Audits were presented by Richard Treece, Planner with AP Architects and President Carole Goldsmith, WHCC.

The Committee takes periodic tours of the construction projects to review the progress; although none were taken this past year. Any questions or concerns can be discussed on the sites so that a full understanding of all projects is achieved

Any changes in the status or budgets of the projects are discussed openly and fully to the satisfaction of the Committee.

#### V. Establishment of Committee Member Terms:

Establishment of terms for Committee Members as well as voting for continuation of membership or replacement of members due to expiration of term or resignation of members is the duty of the WHCCD Board of Trustees. All original Committee Members will serve an initial two (2) year term with two (2) Committee Members to draw lots, to determine an additional one (1) year term assignment. The Committee Bylaws state that all members may serve a maximum of three consecutive terms.

# VI. Projects:

#### VII. Audit:

As dictated by state law, the SFID-1/ Measure Q bond requires a financial and performance audit which examines the usage of the bond funds. The firm of Vavrinek, Trine, Day & Company, LLP audited the SFID-1/ Measure Q bond program for the fiscal year 2014 / 2015 ending June 30, 2015.

The financial and performance audit report fiscal year 2014 / 2015 was presented to the Committee during its April 5, 2016 annual meeting and the financial and performance audit was supportive of the program and its management.

The auditor's report gave an unqualified opinion that the financial statements fairly presented, in all material respects, the financial position and changes of the SFID-1/ Measure Q bond fund in conformity with accounting principles and generally accepted accounting standards. There were no audit findings reported in the prior year's schedule of financial statement findings.

In regards to the performance audit, the auditor's report noted no instances of noncompliance with the terms of Prop 39 for SFID-1/ Measure Q. Nothing examined came to auditor's attention to indicate that WHCCD didn't implement appropriate management controls to ensure the bond proceeds are administered economically, efficiently and effectively. There were no questioned cost and they were no audit findings reported in the prior year's schedule of financial statement findings.

## VIII. Statement of Compliance:

Based on the information provided by WHCCD, the Committee finds that as of this reporting for SFID-1/ Measure Q from July 1, 2014 to June 30, 2015, that WHCCD is in compliance with the standards of Article XIIIA Section 1(b) 3 of the California State Constitution and the terms of the original bond ballot.
